If the customer does not use an existing PEC pole for outdoor lighting, there is a one-time charge of \$100 and an additional \$1.50 per month for each pole required.

## Deposit Requirements

| <u>Commercial Deposit</u>  | Est. Monthly Bill (X) 2 (Minimum \$200.00)                                |
| <u>Connect Fee</u>         | \$30.00   |

In addition, any residential homeowner or renter who shall have had electric service discontinued for non-payment more than once in the past 24 months will be required to pay a minimum security deposit of \$200.00.
