Renters	\$200.00 (rental agreement or receipt of rental payment will be required)
Commercial Deposit	Est. Monthly Bill (X) 2 (Minimum \$200.00)
Connect Fee	\$40.00

In addition, any residential homeowner or renter who shall have had electric service discontinued for non-payment more than once in the past 24 months will be required to pay a minimum security deposit of \$200.00.
